Medicines fulfilling the criterion of standards shall provide to be beneficial. AYUSH Systems of medicines do mention about standards of various formulations, posological principles in a comprehensive way. Though these products have medicinal values and are beneficial for human health; they can carry a risk of developing adverse effects when used inappropriately. On the whole, there is a scarcity of information on the safety aspects of AYUSH formulations and there is a need for better documentation and generation of evidences. Thus a vigilance and awareness among the stakeholders is needed which further refine the clinical practices and facilitate in minimising further mistakes in clinical practice. Based upon such documents, evidences can be generated on scientific lines and enhanced public trust too. With this background **PharmaCovigilance Program** for ASU & H Drugs is initiated by the Ministry of AYUSH to inculcate reporting culture of suspected ADRs and also to be vigilant against objectionable advertisements.






